2012 SCHOOLING SHOW ENTRY FORM**

- Riders may enter a PVDA schooling show using (1) mail, or (2) the PVDA web site ([www.pvda.org](http://www.pvda.org)) (an additional PayPal fee will be added to the class fees).
- Rider must be a current PVDA member.
- Entry fees are \$25.00 per class.
- Telephone entries will not be accepted.
- The entire entry form must be completed. Please note instructions for completion of bottom of the form (below DO NOT DETACH).
- Please see the 2012 PVDA Show Schedule for tests offered.
- Contact the Show Manager for availability of Dressage Seat Equitation.
- Indicate which test(s) you want to ride (you may list alternate tests in the event that classes/rides are to be limited).
- For mail submission, mail (1) completed **entry form**, (2) **entry fees** (check made out to PVDA), (3) copy of **PVDA membership card**, (4) copy of **current negative Coggins**, and (5) **self-addressed stamped envelope** (if you want to have your ride times mailed to you) to the show manager listed in the PVDA Show Schedule booklet and web site (check the web site for any changes).
- For web site submission, please see the instructions on the web site.
- Ride times will be posted on the PVDA web site by the Monday before the show.

**NOTE: A separate entry form must be submitted for each horse/rider combination.**
